Procedure to deal with Vacant Seat e-Admission (Phase-II) in Higher Secondary Schools for the Session 2025-26

Eligibility Criteria:

- 1. Applicants should have successfully passed the **High School Certificate (HSC)** Examination conducted by the Board of Secondary Education (BSE), Odisha or any equivalent Board.
- 2. Vacant seat admissions will be made **purely on merit**, without any reservation or weightage.

Instructions:

- 1. It is strongly recommended that applicants and their parents/guardians review the "Common Prospectus" on the SAMS portal thoroughly prior to filling and submitting the online CAF.
- 2. Applicants must pay the CAF fee **online** only, as outlined in the Common Prospectus.
- 3. Applicants of Phase-I e-Admission 2025-26 who did **not secure selection** in any Higher Secondary School can re-apply through their registered login without additional CAF fee payment.
- 4. In addition to **Point No. 03**, applicants who were **admitted in Phase-I, selected but not admitted, failed to apply CAF in Phase-I, or took TC (General/Slide-up) on or before 31st August, 2025**, must submit a fresh CAF with fee payment in the Phase-II 1st Selection process.
- 5. The Common Application Form (CAF) can be modified by applicants up to **four times** only.
- 6. Submit your own application and select the Higher Secondary School of your choice. Avoid letting anyone else apply for you.
- 7. Applicants should complete the online CAF with utmost care, as mistakes may result in rejection.
- 8. The list of Higher Secondary Schools with vacant seats will be provided only for applicants' preference and selection.
- 9. Applicants are required to produce and verify all relevant documents at their selected Higher Secondary School during admission.

10. For Phase-II, at the time of applying through CAF, if a Higher Secondary School has zero vacancies, candidates will not be able to opt for it, and an alert message will be displayed:

"Currently there is no vacancy. If vacancy arises, then your preferred choice/option will be taken into consideration in the selection process."

- 11. Applicants may select their preferred Higher Secondary Schools and Streams, regardless of current vacancies. Allotment will be made strictly on the basis of seat availability as on 31st August, 2025, including vacancies created during the application period. No claim shall be entertained for vacancies arising after this date. The responsibility for choosing and applying to suitable options rests entirely with the applicants.
- 12. For the Phase-II 1st Selection process, the 'Surrender TC' option will be disabled in the HSS e-Space login from 01.09.2025 to 11.09.2025.
- 13. Phase-II SPOT Selection will not be open to candidates admitted to their 1st choice HSS in the Phase-II 1st Selection.
- 14. All applicants, whether **non-selected or selected but admitted to a lower option, not admitted, or requiring corrections**, may give fresh options during the Phase-II online SPOT Selection.
- 15. Students admitted to any HSS, but subsequently selected in a different HSS under Phase-II, are required to bring the original Higher Secondary School Leaving Certificate (**HSSLC**) from their previous institution at the time of admission.

Procedures:

- Fresh candidates are required to create an account on www.samsodisha.gov.in with their mobile number and email address. Applicants who have registered earlier may use their existing login details to apply again.
- 2. All other processes, including application submission, shall be carried out as per the provisions mentioned in the "Common Prospectus" available on www.samsodisha.gov in for e-Admission.
- 3. Applicants will be notified of their selection and reporting time via SMS/WhatsApp, SAMS login, HSS merit list on www.samsodisha.gov.in, and

the HSS notice board. An intimation letter will be available in the applicant's login and shared through WhatsApp only for Phase-II 1st Selection.

N.B.

- 1. In the Phase-II SPOT Selection process, applicants may choose their preferred Higher Secondary Schools and Streams, irrespective of current vacancies. Allotment will be based on vacancies available as of 13th Sept. 2025, including those arising during the application period. No claim shall be entertained for vacancies occurring after this date. The selection of options is solely the responsibility of the applicants.
- 2. For Phase-II SPOT Selection process, at the time of applying through CAF, if a Higher Secondary School has zero vacancies, candidates will not be able to opt for it, and an alert message will be displayed:
 - "Currently there is no vacancy. If vacancy arises, then your preferred choice/option will be taken into consideration in the selection process."
- 3. For the Phase-II SPOT Selection process, the 'Surrender TC' option will be disabled in the HSS e-Space login from 14.09.2025 to 24.09.2025.
- 4. For SPOT Selection, the Higher Secondary School Leaving Certificate (**HSSLC**) will not be generated automatically along with the Intimation Letter.
